Pursuant to Article 61 of the Higher Education Act of Herzegovina-Neretva Canton (Official Gazette of Herzegovina-Neretva Canton, No. 4/12), Article 63 of the Articles of Incorporation of the University of Mostar (No.: 01-1875/20 dated March 5 2020), Article 2 of the Rulebook on Rewarding and Commending Students and the Decision on Amendments to the Rulebook on Rewarding and Commending Students of the School of Medicine of the University of Mostar, the Dean approved the following:

DECISION ON ANNOUNCING A CALL FOR APPLICATIONS FOR REWARDING AND COMMENDING STUDENTS

Article One

The call for applications for awarding and commending students of the School of Medicine of the University of Mostar for the academic year 2023/2024 has been being announced, as follows:

- Dean's Award
- Commendation for extracurricular activities

Article Two

The Dean's Award is awarded to one student from each year of study, who achieved the highest grade point average and who had not previously received the award.

The minimum grade point average that students - candidates must achieve in order to compete for the award is 4.50, and the grade point average in the academic year in which the student competes for the Dean's Award must be 5.00.

Students - candidates for the Dean's Award in a particular year of study, except for those mentioned in paragraphs (1) and (2) of this Article, must be enrolled as full-time students in the following year, have passed all exams from the previous year, and fulfill the condition that they did not repeat a year during their studies. If two students have the same grade point average, preference will be given to the one who took a certain exam fewer times.

Article Three

Students - candidates for the Commendation for extracurricular activities that have contributed to the School's reputation (international and domestic competitions, presentations at scientific conferences, work in the School's magazines, art or sports groups, work in student associations, etc.) are proposed by the School's Student Council.

Students - candidates for Commendation for extracurricular activities must have an average grade of all passed exams higher than 3.50.



Article Four

Applications for the call with accompanying documentation shall be submitted in person to the School's Secretariat or by registered mail to the address: School of Medicine of the University of Mostar, Kralja Petra Krešimira IV bb (Bijeli Brijeg bb), 88 000 Mostar, with the indication "For the call for awarding and commending students".

Article Five

The call remains open for eight days from the day of publication on the notice board and the School's website.

Article Six

The Decision enters into force on the day of its adoption.
