Pursuant to Article 61 of the Law on Higher Education of HNC (Official Gazette of the Herzegovina-Neretva Canton No. 4/12) and Article 63 of the Statute of the University of Mostar (Ref. No.: 01-1875/20 of March 5, 2020), the Dean of the School of Medicine of the University of Mostar issues the following

DECISION

I.

III.

The mandate for the appointed coordinators/mentors lasts until the end of the 2024/2025 academic year.

IV.

This Decision shall enter into force on the date of its adoption.

EXPLANATION

In order to improve the quality of the teaching process at the School of Medicine of the University of Mostar, as well as to ensure more direct communication with students and their potential needs and requests, the Scientific-Teaching Council has determined that there are justified reasons for appointing coordinators/mentors.
